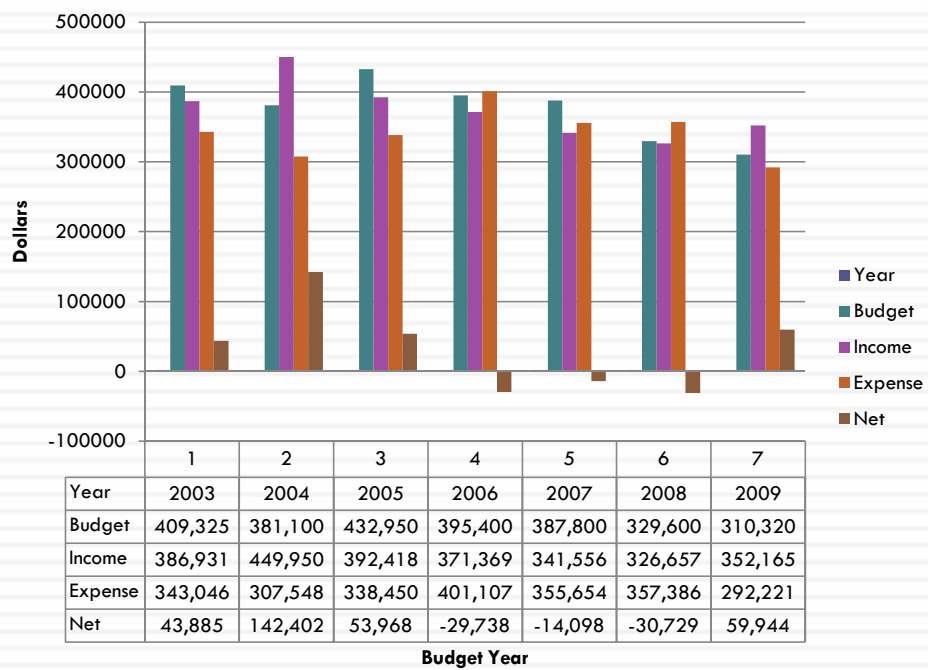

IAWP Finances 2003-2009

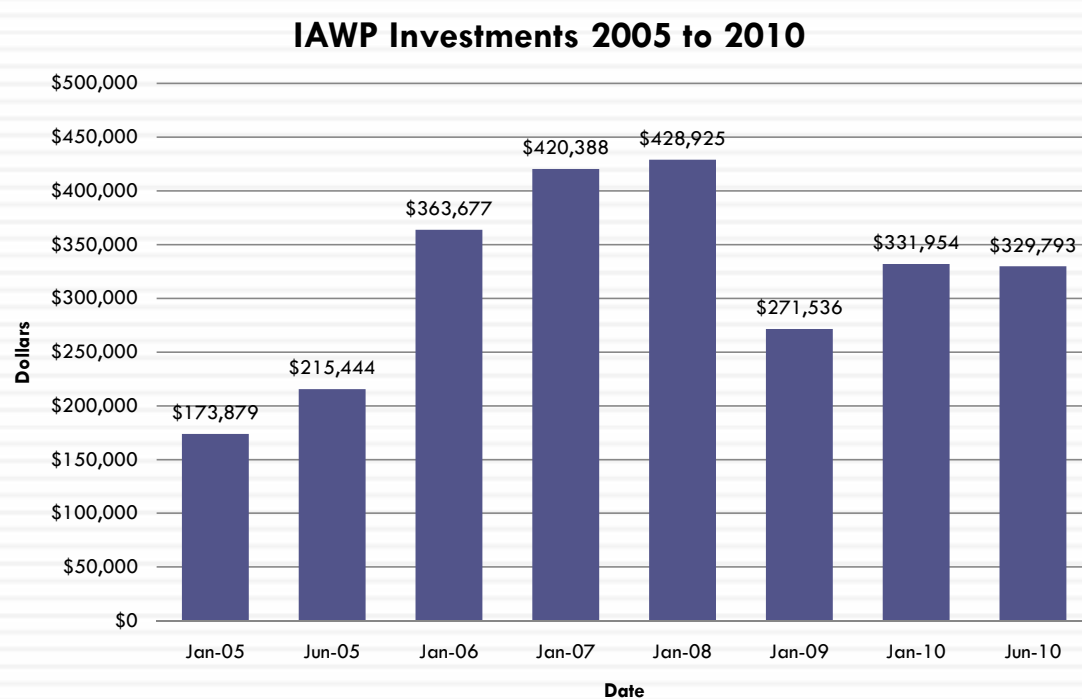


2009 & 2010 Finances

- Budgeted Income and Expenses - \$310,320
- Actual Income - \$352,165 (this included \$21,651.35 of one-time room commission money from Richmond and Rapid City)
- Actual Expenses - \$292,221
- 2010 ended year about \$15K in the red
 - ▣ Two board meetings in one year
 - ▣ Full audit versus review
 - ▣ Office equipment purchased
 - ▣ Greenville broke even to the penny

- ***We have paid off all debt the Association incurred in previous years and finished the year in the black***

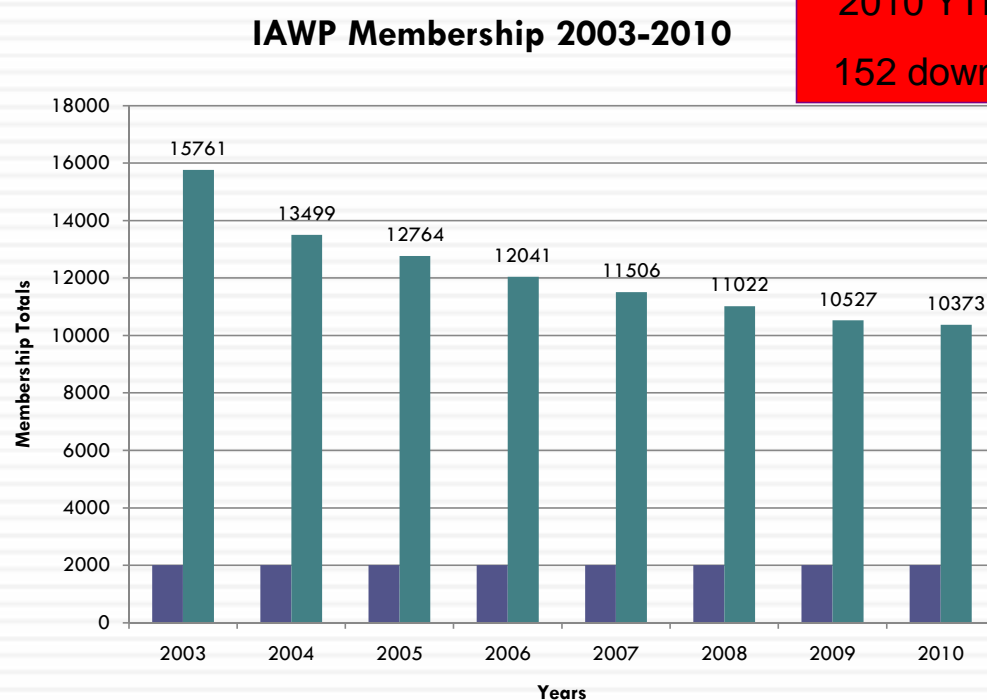
Stewardship Report - Investments



Investments are on the Rebound

- As of December 31, 2009 our investment portfolio is valued at \$331,954
- We are within \$31,722 of our portfolios balance in January 2006
 - ▣ This is in part due to the recovery on Wall Street
 - ▣ But also because of sound investment strategies by our BOD

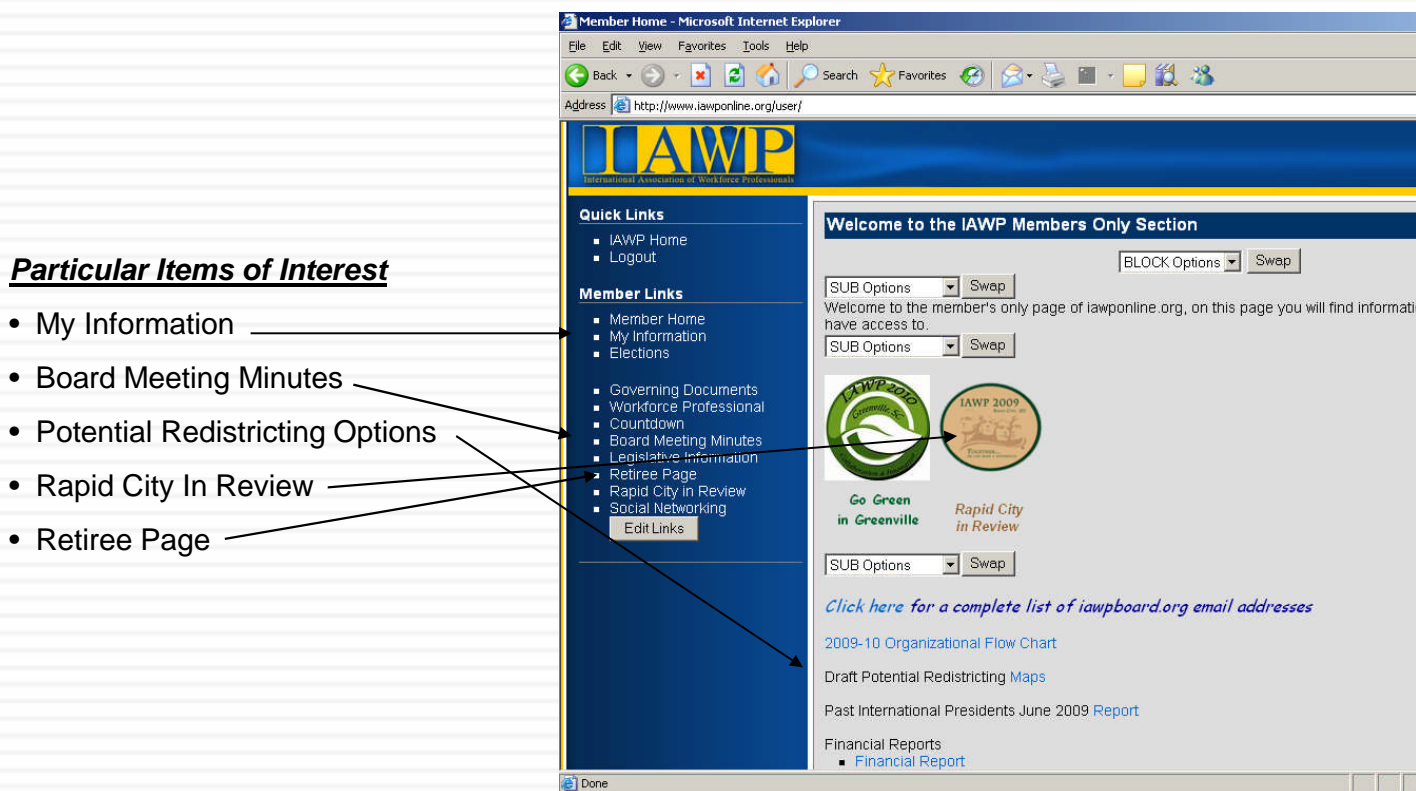

Recent Board Actions

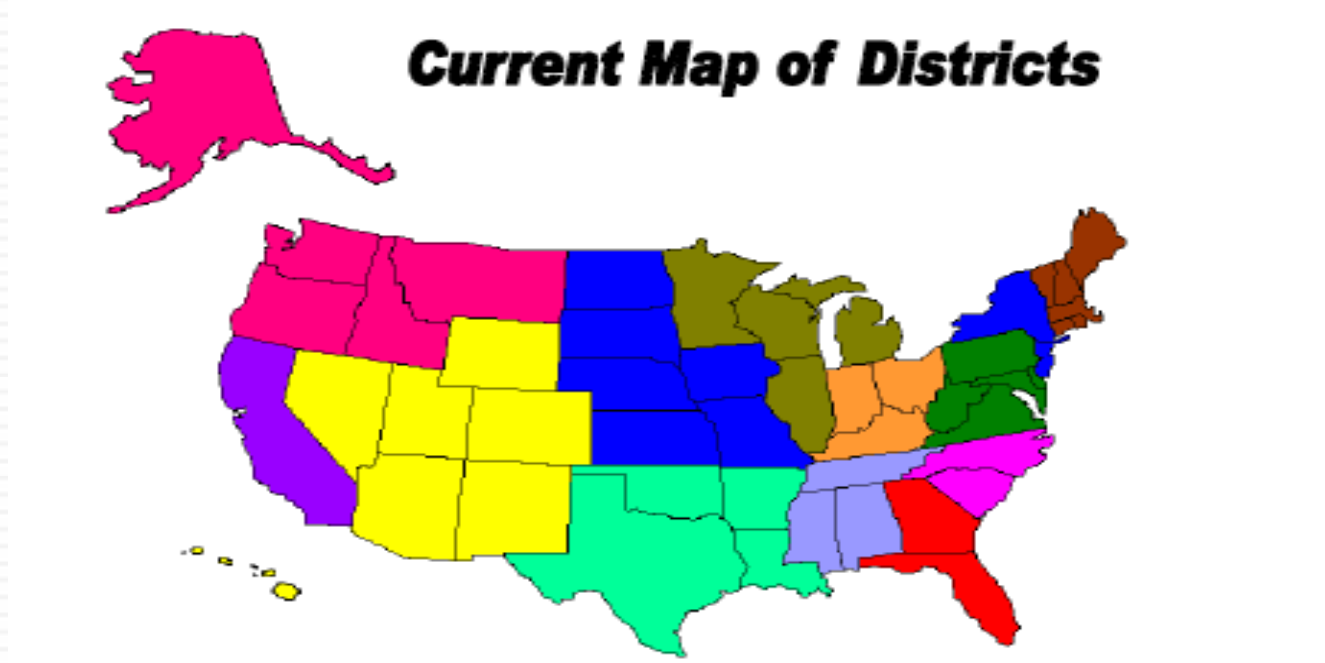
Communicate: All Levels Enhancing JAWP

- In 2010 voted to increase dues by \$8 for full members and \$4 for retiree members, effective January 1, 2011. Recently moved this to January 1, 2012.
 - This equates to \$0.67 a month for full members and \$0.33 a month for retirees.

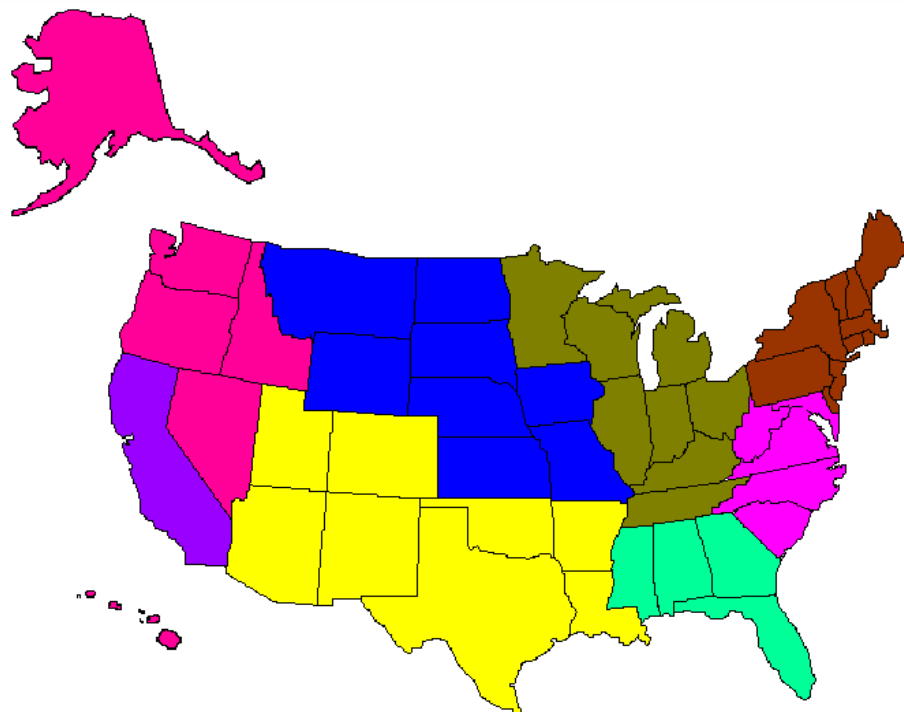
